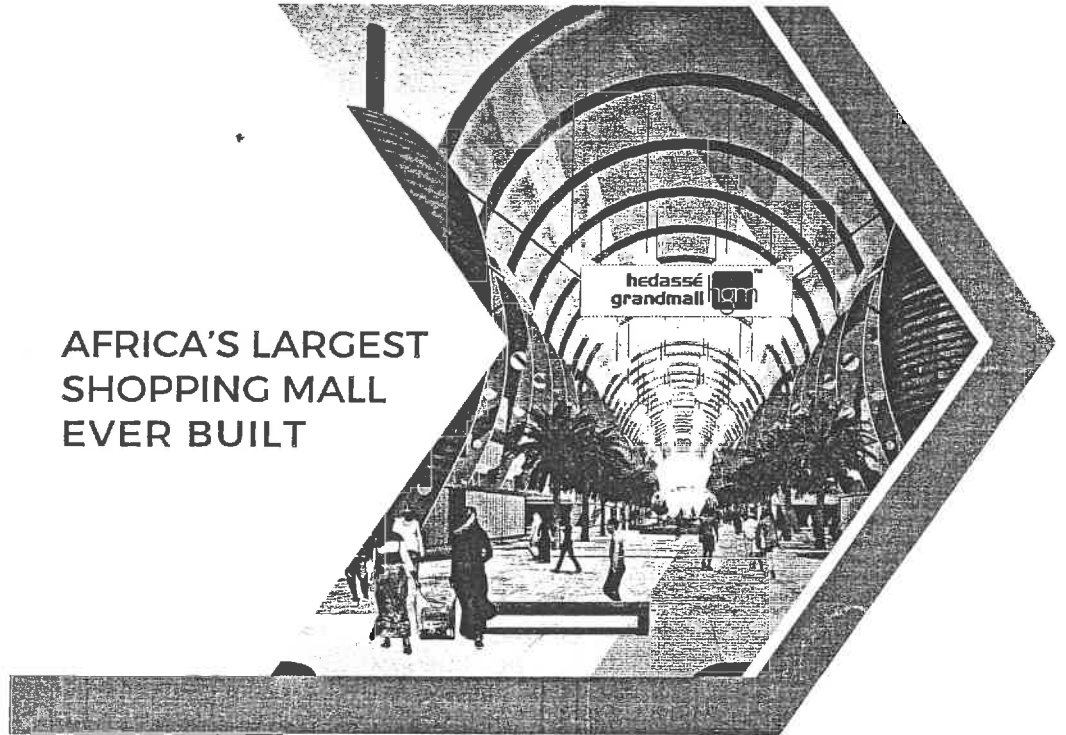

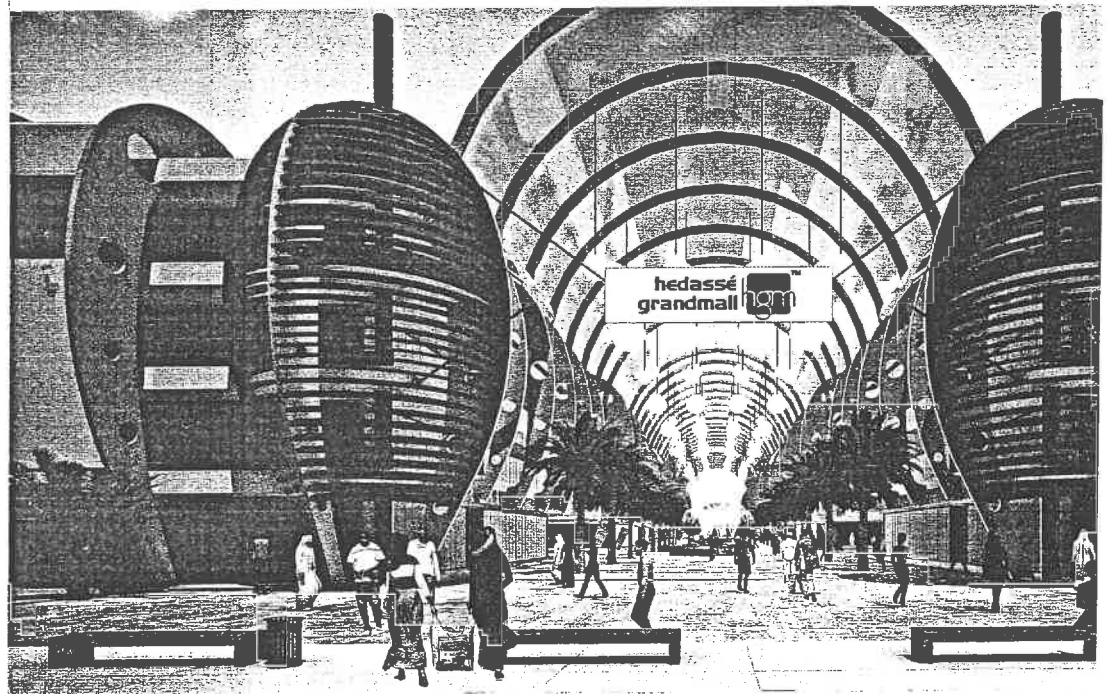
The company has got its foundation in 2013 and conducts many research and development to decide the area of business that benefits the shareholder as a business and the country for its renaissance.

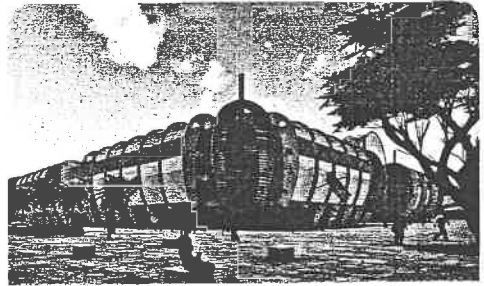
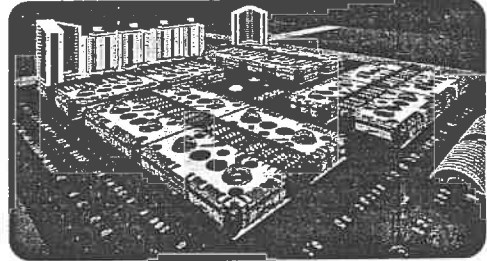
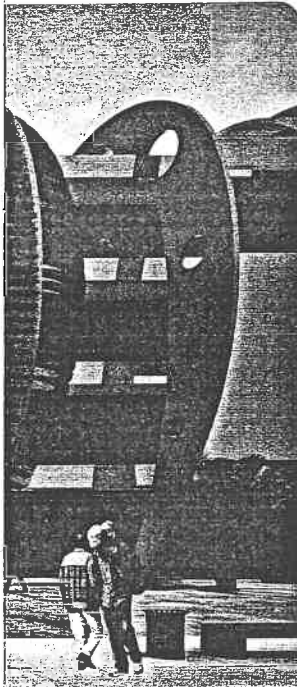
## Hedassé Grand Automotive Market
